Institution's international strategy

1. The RCSMM chooses its' partners according to several academic strategies, such as:

- proximity of the study plans. We care very much about the continuing the academic tasks that our students have begun, the subjects and ETCS proposed in each Institution has to be similar to ours so that the student could fluently pass from home institution to the host one.
- the extra academic and music activities proposed in the host institution. Being an Institution for Artistic (Music) área, it is very important to us that the students could develop their artistic skills, to get acquainted to a different musical context which can enrich them enourmously for their artistic growing up.
- the quality of staff and teachers in the host institution. The Real Conservatorio de Música de Madrid has a high qualified teachers and we try that our students approve their academic and artistic abilities in the same professional level

2. The Real Conservatorio Superior de Música de Madrid has Bilateral Agreements with institutions all over Europe, no matter the geographical áreas. We strongly believe that develope the contacts between different nations and customs enriches and helps international relationship.

3. The RCSMM relies on a fruitful partnership between each institution and itself. Our principal objectives for each institution are:
